## Delivery

On delivery, the person accepting delivery shall be required to sign and print his/her name as against a duplicate copy of the delivery note as confirmation of delivery. Should no-one be in attendance at the time of delivery, the courier will retain the products and a notice will be left at the delivery address to this effect. Our representative will attempt to contact you to make new arrangements for delivery or collection.

On delivery of the order to the specified delivery address, you will receive a Lutzville delivery note showing the items delivered, prices and value-added tax and the amount to be debited or which has been debited from your card.
